## Please read the following before signing:

1. Every effort has been made to ensure that this dog is healthy in body and mind, and is sold subject to it being understood that as a living creature it is impossible to predict how it will continue to develop, especially as regards to behavior over which the new owner will have the principal influence.
2. It is recommended that the new owner check with a vet about potential health problems with the breed before purchase.
3. After purchase the new owner will have a **48hr period** in which it is highly recommended that they take their new dog to a vet and have it examined.
  - a. If there is a problem found by a licensed vet, within the allotted window of time then a full refund is available, and the dog will be returned to the breeder.
4. **2 Year Genetic Defect Guarantee**
  - a. This guarantee covers: hip dysplasia, fatal heart disorder, and canine eye disease
  - b. If the dog is found to have an inherited genetic defect by a licensed vet in first 24 months of its life, contact the breeder immediately. Proof provided by the vet and the dog's registration number will need to be sent to the seller. The dog can then be returned to the breeder and the buyer will receive another puppy free of charge when one becomes available.
  - c. This health guarantee is only between the seller and buyer: if the dog is rehomed, then it will be voided.
5. **The purchaser agrees not to sell the dog to any agent or pet store.** If for any reason after purchase the new owner is unable to keep the dog, they are *required to contact the breeder first* to make arrangements to find a new home. Under no circumstances will the dog be allowed too be resold to an agent or pet store.
6. ( ) This dog **IS SOLD** on a non-breeding contract. Upon proof from the buyer's vet of spay/neuter provided to the breeder, their individual registration papers with the Continental Kennel Club will be forwarded to the buyer.
  - a. If it is found that said dog has been bred, while under this contract, the buyer will be fined \$2000, and dog must be returned to the original breeder.
7. ( ) This dog is **NOT SOLD** on a non breeding contract. Papers will be provided with final payment for the puppy.
8. **Should the buyer be found negligent by the seller of any of the terms and conditions stated above, then it is hereby mutually agreed that the seller may repossess his/her dog without legal repercussions by the buyer. No refund would be paid or expected in this instance. All attempts would be made by the seller to help resolve the situation before this time, if asked.**
